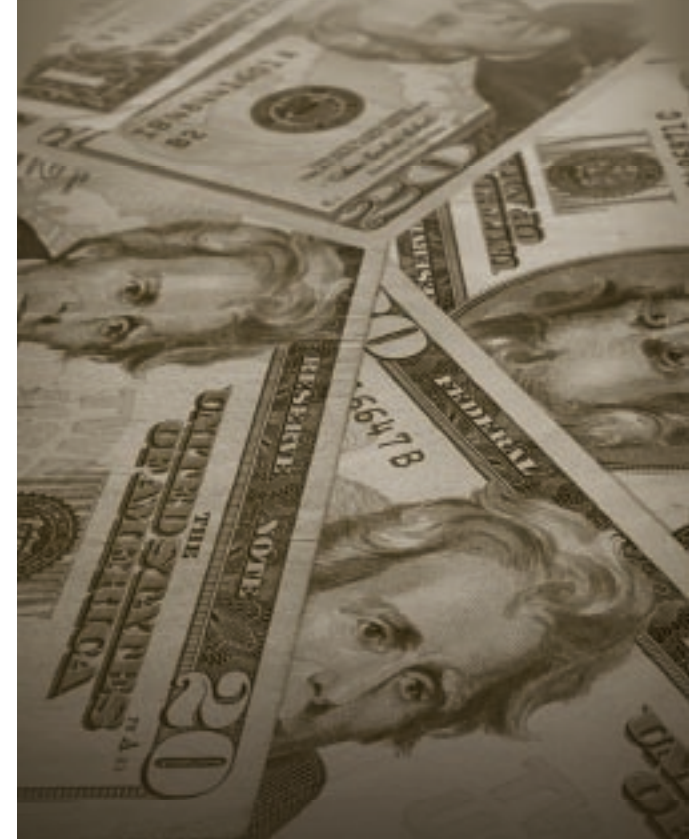

Tax Credit Program

Take a look at the credits you may be qualified for:

Federal

The Federal government has many programs offering substantial credits including:

Work Opportunity Tax Credit (WOTC) Program—Up to \$2,400 per employee

WOTC works for companies with employees who fit in one of these categories:

- AFDC recipient
- Veteran on welfare
- Vocational rehabilitation referral
- Summer youth
- Ex-offender
- Supplemental Security Income recipient
- Food stamp recipient
- High-risk youth
- Enterprise Zone resident
- Rural renewal county resident

Welfare to Work—Up to \$9,000 per employee

The objectives of this Federal program are to help individuals move off of welfare through employment. In January, 2007 it was combined with WOTC.

Empowerment Zone—Up to \$3,000 per employee per year

Empowerment Zones partner Federal, State and local governments to help stimulate renewal in distressed urban neighborhoods and rural areas. Special emphasis is placed on economic growth and social development that strive for long-term change and demonstrates working partnerships among various governmental entities. To receive this Federal government credit your employees must live and work in the Empowerment Zone.

Renewal Community Zone—Up to \$1,500 per employee per year

The Renewal Community is a federal designa-

tion for low-to moderate-income areas in large metropolitan areas. Its objective is to persuade businesses and developers to invest in these neighborhoods to further stimulate economic development and job creation. To receive this Federal government credit your employees must live and work in the Renewal Community Zone.

State

Each state varies, but here are some examples of credits we commonly pursue:

- Enterprise Zone credits
- Hiring disadvantaged workers
- Hiring credits and refunds
- Job creation credits
